# RESOLUTION HONORING RENSSELAER COUNTY VETERAN AIRMAN HUMBERT POLI

WHEREAS, It is consistent with the duty of this Legislative Body to recognize achievements of the citizens of Rensselaer County, we acknowledge with respect and admiration individuals whose bravery and dedication have been so valuable to our community; and

WHEREAS, Rensselaer County owes a great debt to the men and women of our loyal Armed Forces who so bravely stand ready to preserve our American heritage; and

WHEREAS, Humbert Poli was born on November 30, 1929 in New York City to the late Archibald and Anna Frone Poli; and

WHEREAS, Humbert belonged to the Army National Guard while in high school and in 1952 the United States Army wanted to recruit him for the Korean War but instead he enlisted in the United States Air Force on April 6, 1952; and

WHEREAS, The Korean War was significant in the fact that it was the first war in which the newly independent United States Air Force was involved; and

WHEREAS, Humbert trained at Samson Air Force Base in New York and then Kessler Air Force Base in Mississippi where he trained as a High Speed Radio Operator using a telegraph transmitter all while obtaining his High School Diploma; and

WHEREAS, As a Ground Radio Operator, Humbert deciphered Morse Code transmission received and sent from base as well as aboard the Douglas C-47 Skytrains during surveillance flights in order to transmit information back to the base; and

WHEREAS, On April 30, 1955 while in the States on a two month leave, Humbert married his high school sweetheart, Ellen Ford and promptly headed to Ellington Air Force Base in Houston Texas where Humbert served as a Ground Radio Operator using the Military Auxiliary Radio System and Ellen, a Registered Nurse, worked on the base; and

WHEREAS, Humbert was honorably discharged on April 6, 1956 and relocated to Poughkeepsie, New York where he began working for Western Electric, setting up their Communication Center; and

WHEREAS, After being honorably discharge, Humbert continued to serve his country, in the Air Force Reserve from 1958 until 1961 and in the Air National Guard from 1961 until 1964; and

WHEREAS, Humbert and his family eventually moved to Snyder's Lake; and

WHEREAS, Humbert retired at the young age of fifty-five after thirty years of service with the United States Postal Service; and

WHEREAS, Humbert and his late wife, Ellen, had six children, Kathleen, Michael, Terri, Mark, Patty and Matt as well as eleven grandchildren and eleven great-grandchildren; and

WHEREAS, For his service, Humbert received the Korean Appreciation Medal, the United Service Medal, the National Defense Medal and the Korean Service Medal; and

WHEREAS, Humbert is a member of the American Legion Post #1775, the VFW Florida Post #8108, the Korean War Association, Local & National NE Chapter, the Komaki Air Force Base NAGOYA Reunion Association, Inc. and the Sampson AFB Veteran's Association; now, therefore, be it
